Registration Process

Five-Day Training Program - Our five-day in-person training program is the most comprehensive way to learn this material. To register for the course, please send the following to As You Wish ED:

- ✂ One professional reference
- ✂ Signed Application

Upon receipt of your application packet, we will review all of the materials and send an acceptance letter within two weeks. The balance of \$699 is due 30 days prior to the first day of the course.

Home Study Course- To register for the home study course, please send the following to As You Wish ED:

- ✂ Completed Application
- ✂ \$300 non-refundable Application Fee (check only)
- ✂ One personal character reference
- ✂ One professional reference
- ✂ Signed Application

Upon receipt of your application packet, we will review all of the materials and send an acceptance letter within two weeks. The balance of \$549 is due within 30 days. As soon as we receive your payment, the program will be mailed to you. You have one year to complete the course.

*The home study course involves a numerous assignments. These assignments need to be mailed to As You Wish ED for grading within one year after starting the course. You will receive your certificate of completion within three months of As You Wish ED receiving your assignments.

Terms

Role. This agreement (hereinafter referred to as "Agreement") between As You Wish Wedding & Event Design Education Division (hereinafter referred to as "As You Wish WED – ED") and the Client signing below is for services to be rendered by As You Wish WED - ED and compensated by the client as stated herein. As You Wish WED - ED's role is that of an advisor and/or teacher.

Deposit and Payment. The Client shall provide a deposit to retain As You Wish WED - ED to perform the services specified herein. Upon completion of this service, the deposit shall be applied to reduce the cost and Client shall pay the balance due thereof. If the Client refuses to pay within thirty (30) days of the date specified on this contract, Client shall be in default and shall pay 3% interest monthly on the unpaid balance until payment is made in full.

Cancellation. To cancel this contract, the Client must notify As You Wish WED - ED in writing. In the event of the Client's cancellation, the retainer will not be refunded. If the Client cancels less than one month prior to the event, As You Wish WED - ED shall retain the additional deposit.

Partial Performance. By signing this Agreement, the Client agrees that once As You Wish WED – ED's services have commenced, the Client may not decline the services of As You Wish WED- ED and refuse to pay the entire balance due thereof. If As You Wish WED – ED is ready, able and willing to continue providing the service agreed upon in this Agreement, then As You Wish WED – ED shall receive full compensation as provided in this Agreement.

Failure to Perform. If As You Wish WED - ED cannot perform this Agreement due to a fire or other casualty, strike, act of God, act of nature, illness, or any other cause beyond the control of As You Wish WED - ED, then As You Wish WED – ED shall keep the retainer, but return all other monies paid to the Client. Additionally, As You Wish WED – ED shall have no further liability with respect to this contract.

Planner Substitution. In the extremely unlikely event of a severe personal illness or other extreme acts of God or nature beyond the control of As You Wish WED – ED, which precludes As You Wish WED - ED from performing the duties of this contract, As You Wish WED - ED will attempt to arrange for a substitute planner of high qualification. The Client and As You Wish WED - ED both assume the risks and dangers of the planner's travel. In the extremely unlikely event that a last-minute act of God, nature or travel disaster occurs while As You Wish WED - ED is en route to the event, As You Wish WED - ED agrees to refund the client all monies paid, less the retainer.

Miscellany. This Agreement incorporates the entire understanding of both parties. Any modifications of this Agreement must be in writing and signed by both parties. This Agreement shall be governed by the laws of the State of New Jersey. In the event of litigation regarding this Agreement, the prevailing party shall be entitled to reasonable attorney's fees and related expenses.

The parties have read all pages of this Agreement, agree to all its terms, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as client below shall be fully responsible for ensuring that full payment is pursuant to the terms of this agreement.
